# RULES & REGULATIONS / ENTRIES

## HUNTER, JUNIOR / AMATEUR JUMPER ENTRIES CLOSE 5:00 PM WEDNESDAY, SEPTEMBER 2, 2026

- ALL ENTRIES MUST BE SUBMITTED ELECTRONICALLY: The National Horse Show will use the Show Management System On-line Entry Platform to accept electronic entries and to manage the qualification process for all competitors. Show Management System's™ \$7.50 Entry Processing Fee enables exhibitors to submit an electronic entry, to receive e-mails regarding their qualification and wait list status, and to use credit cards to pay their entry and show fees and to order optional items. All competitors must submit their show entries on-line at <https://entries.showmanagementsystem.com>.
- All entries must be accompanied by a non-refundable \$150 application fee. Entry and stall fees will be invoiced. Those fees will be invoiced with the acceptance letters to qualified entries.
- Acceptance letters will be emailed in mid-September. Payment in full as billed on the acceptance invoice must be submitted electronically by the specified date; entries not paid in full by the specified date will not be permitted to show.
- A mandatory non-refundable office fee of \$100 and an ambulance fee of \$50 will be assessed for each qualified and accepted entry.
- Non-negotiable checks or declined credit cards will disqualify the entry, and the exhibitor will be charged a \$150 collection fee. Exhibitors with outstanding debts to NHS will not be allowed to compete.
- Post entries will only be accepted if time and space in the schedule allow and will be charged a \$100 post/late entry fee.

***Do not email Coggins tests, or Health certificates.***

***These documents must accompany the horses on arrival. See page 19 for more information.***

***No substitution/changes of horses may be made after the announced closing date of entries.***

Once the qualifying lists have been posted on the NHS website, a grace period of five (5) business days will be granted to request a correction for a horse that has been clearly entered incorrectly, having no points or is ineligible for the division in which it was entered. The request for a correction will be considered only for horses with on-time entries that have been received in the Horse Show Office by the closing date of entries. Any requests for a correction must be submitted in writing to [showoffice@nhs.org](mailto:showoffice@nhs.org) and must be supported by the horse's USEF record. The NHS will review all requests for a correction and make the final decision. Any corrections that are made will not affect entries that have already been accepted into a section.

After the closing date of entries and after the above stated grace period, any requested change of an entry constitutes a new/late entry and shall be placed on the bottom of any existing wait list in that requested section. Exhibitors shall be held responsible for their entries and fees of all horses entered by them or by their agents. After the entry closing date, if an entry is scratched or declined it may only be re-entered as a late entry and added to the bottom of any wait listed entries.

# QUALIFICATION REQUIREMENTS

## HUNTERS

Qualifying will be based on the USEF National Horse of the Year points in Channel I competitions, or money won where applicable, earned by horses from their best 15 shows starting on or after August 27, 2025, through shows starting on or before August 26, 2026. Point totals will be verified with USEF. ***Approximately fifteen (15) horses will be accepted in each of the following sections (Young Hunter see page 28):***

- Any horse applying for acceptance in a section must have shown in that section within the specified qualifying time period but need not necessarily have won points.
- If any section does not achieve the desired number of horses, then another section may be adjusted accordingly to reach the desired number of entries. If the qualifying list is exhausted and spaces are still available in a section, post entries received after 5:00 PM September 2 will be considered on a first-come-first-served basis. Post entries may be accepted only if time allows and will be charged a \$100 post/late entry fee.
- The 2025 National Horse Show Champions in each of the Junior Hunter and Amateur Owner Hunter divisions, the High Performance Conformation and the High Performance Hunter section automatically qualify for the 2026 National Horse Show in the size and height in which they competed and were champion. Only the same horse/rider combinations who were champion in 2025 may move from the younger section to the older section of their respective division retaining its championship status therefore qualifying 2026.
- In each section, Champion and Reserve Champion titles will be awarded to the top two of the four horses that acquired the most points performing over a regulation course with obstacles at the required height. In addition to these points, only these four horses receive full points for ribbons won in one Under Saddle class.
- All hunter classes except for Adult Hunter Classic and Young Hunter Championship, are held in accordance with USEF HU118 Option A jogging for soundness: Horses are required to trot a circle on a loose rein at the end of each over fences performance.
- **ADULT HUNTER CLASSIC:** Entries in class 26 Adult Amateur Hunter Classic will be accepted on a first come first serve basis. See page 27 for full class specifications.

- Entries for classes 1 – 18 will be accepted on a first come first serve basis and are limited to only those entries showing in classes 19, 20, 21, 22, or 26.
- Entries for classes 19, 20 and 21 The NHS Adult Equitation Championships sponsored by THIS will be accepted based upon the criteria outlined in the class specifications found on [www.nhs.org](http://www.nhs.org).

## PRIZE MONEY

- All entries must be accompanied by a W-9 form in order to receive prize money.
- Prize money will be credited to entry show account. All prize money in excess of balances due will be mailed to the payee as listed on the entry form, within 30 days of the completion of the show. IRS 1099 Miscellaneous Income Forms will be issued to the payee as listed on the entry form.
- **Foreign competitors:** The U.S. Internal Revenue Service requires sporting events to withhold 30% of prize money won in the United States. Foreign competitors requesting a treaty exemption need to have a Federal Taxpayer Identification Number (ITIN, SS#, TIN), and will be required to complete a form W-8BEN, W-8BEN-E indicating the Article number of the treaty exemption, or a form W-8ECI (no Article number required).

## STABLING

Barns 1-5 feature permanent 10' x 12' stalls of wood/metal construction available at a cost of \$450 per stall per week. Stalls feature matted flooring over stone dust, individual fans, and sliding doors.

The Horse Show Office cannot accommodate splitting stalls. Early or late stabling must be arranged through the Stable Office and will be billed at \$100 per stall, per day.

Competitors may select from any available stabling option. Stabling will not be separated by discipline, and all assignments, including Premium Stalls, will be made on a first-come, first-served basis.

### Limited Premium Stalls

A limited number of premium stalls will be available each week on a first-come, first-served basis. These stalls are located within the Indoor Complex and are available at a cost of \$650 per stall, per week. Please note that Week 2 orders cannot be guaranteed early arrival before the designated move-in date.

### Week 1

**October 21–25, 2026 / For horses entered in Classes 1–22**

Stalls will be available beginning at 10:00 AM on Monday, October 19 and must be vacated after the completion of the last competition. Early stabling before 10:00 AM on Monday, October 19, or late stabling after 8:00 AM on Monday, October 26, must be arranged through the Stable Office and will be billed at \$100 per stall, per day.

Horses entered in the Adult Amateur Hunter Classic are not required to be stabled on the grounds. If a horse requires stabling, it may be ordered at the time the entry is submitted.

All horses entered in the NHS 3'3" Equitation Championship Sponsored by the Hamel Foundation and the NHS Adult Equitation Championship Sponsored by THIS must have a stall and be stabled on the grounds 24 hours prior to the start of the class and remain on the grounds until finished competing. Any horse that may potentially be used in either championship must be entered and will be assigned a number. This number must be displayed at all times whenever the horse is outside of its stall, mounted or unmounted.

### Week 2

*Qualified Hunters, Jumpers & NHS ASPCA Maclay Stabling*

**October 27–November 1, 2026**

Stalls will be available beginning at 8:00 AM on Monday, October 26 and must be vacated by 8:00 AM on Monday, November 2. Early stabling before 8:00 AM on Monday, October 26, or late stabling after 8:00 AM on Monday, November 2, must be arranged through the Stable Office and will be billed at \$100 per stall, per day.

Any stalls that have not been vacated by 8:00 AM on Monday, November 2 will automatically be assessed a \$100 per day charge. This charge will not be waived under any circumstances and will be billed through the Show Office.

## REFUNDS

- **Stabling, administration, and nomination fees are non-refundable after the closing date of entries/acceptances.**
- Horses entered in classes 1-26, held October 21-25, may be scratched without a veterinarian's certificate by notifying the Show Secretary in writing via letter, official scratch sheet, or other written correspondence. Provided written notification is received before 8:00 A.M., Friday, October 9, entry fees will be refunded less a \$150 processing Fee. If written notification is received after 8:00 A.M., Friday, October 9, but prior to 8:00 A.M., Wednesday October 21, entry fees will be refunded, less a \$200 processing fee. Unless written notification is received by 8:00 A.M., Wednesday, October 21, no portion of the entries or fees will be refunded.
- Horses entered in classes held October 27-November 1 may be scratched without a veterinarian's certificate by notifying the Show Secretary in writing via letter, official scratch sheet, or other written correspondence. Provided written notification is received before 8:00 A.M., Friday, October 16 entry fees will be refunded, less a \$150 processing fee. If written notification is received after 8:00 A.M., Friday, October 16, but prior to 8:00 A.M. Saturday, October 24, half of the entry fees will be refunded. Unless written notification is received by 8:00 A.M., Saturday, October 24, no portion of the entries or fees will be refunded.

## NIGHTWATCH

All horses occupying a stall, whether showing or not, are required to pay a one time per show nightwatch fee of \$25. This service is NOT OPTIONAL. Horses will be checked 6 times each night beginning at 7:00 PM on Monday, October 19 through 6:00 AM Monday, November 2. It must be properly fitted with harness secured.

## TRYON INTERNATIONAL REGULATIONS

### ELECTRICAL EQUIPMENT

All electrical installation and connections must meet all state and county codes. Aisles will be maintained clear for a minimum of six (6) feet wide by eight (8) feet high. No obstructions or projections shall be allowed in the aisles. No Class 1 Flammable liquids such as gasoline are allowed inside the buildings. Cooking is not permitted within the stable area. Anyone found in violation shall be subject to dismissal from further participation in the horse show without recourse.

### MOTORIZED VEHICLES

Under North Carolina State Laws and USEF rules, unlicensed drivers are not permitted to operate any motorized vehicles - ATV's, motorcycles, golf carts, etc., on the show grounds. Failure to abide by these regulations will subject the exhibitor to suspension from the horse show. See USEF GR 1301.7.

### PARKING

Fire regulations prohibit all vehicles, including trailers, vans and passenger vehicles from being parked in the stable areas. Vans and trailers will be allowed in the stable area only to load or off-load. PARKING AREAS WILL BE DESIGNATED AND VIOLATORS WILL BE TOWED AWAY AT OWNER'S EXPENSE.

## EQUINE HEALTH INFORMATION & REQUIREMENTS

The management of the National Horse Show would like to issue the following requirements to all exhibitors who plan to travel to Tryon International.

1. The state of North Carolina requires that all horses entering the state provide a negative Coggins test within one year of entry as well as a Certificate of Veterinary Inspection (Health Certificate) signed by a licensed veterinarian within 30 days of entry. All horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the grounds and the date of vaccination must be noted on the Certificate of Veterinary Inspection or documented by means noted in USEF GR845. The CVI or an accompanying written statement signed by a licensed veterinarian must document that the horse(s) have not shown symptoms or been treated for EHV-1/4 nor been at a facility under quarantine for EHV-1/4 nor been exposed to any horses showing symptoms of EHV-1/4 during the past 28 days.
2. It is required that all horses arrive between the hours of 7 am and 7 pm. If it is absolutely necessary to arrive at any other time you must call the Stable Office at least 24 hours before arrival to make those arrangements. That telephone number is (859) 414-6266.
3. Please take your horse's temperature on a regular basis so as to establish a normal temperature. Please do not ship any horse with an elevated (101.5 degrees or higher) temperature reading.
4. Twice daily temperature monitoring is required while on the competition grounds. In the event of elevated disease risk or an infectious disease incursion management will notify competitors of mandatory twice daily temperature monitoring and recording (ideally 12 hours apart and prior to any temperature-reducing medication. Any horse with a temperature reading higher than 101.5 or showing any signs of respiratory or neurological disease must be immediately reported to a veterinarian and show management.

**To facilitate the inspection process, this paperwork must accompany the horses upon arrival and be available throughout their stay. This will be a condition of entry to the Tryon International Equestrian Center. Horses arriving without proper paperwork will not be permitted onto the grounds.**

**The National Horse Show utilizes Event Pass, powered by EquiTrace, to manage equine health requirements for the show. Exhibitors are required to complete all applicable health documentation and requirements through the Event Pass system prior to arrival at the National Horse Show.**

## MANAGEMENT

The Management reserves the right to cancel, combine, or split any class if entries warrant or the rules of the USEF require it. Management also reserves the right to change the order of classes or to move classes to another ring. Management reserves the right to decline any entry for any reason and to return money owed before or during the show without being liable for compensation.

The National Horse Show, it's officers, officials and employees will not be responsible for any accident or loss which may occur to an exhibitor, spectator, guest, rider, groom, attendant or other employee, animal or equipment at the show. THIS SHALL BE A CONDITION OF ENTRY TO THE SHOWS OR SHOW GROUNDS.

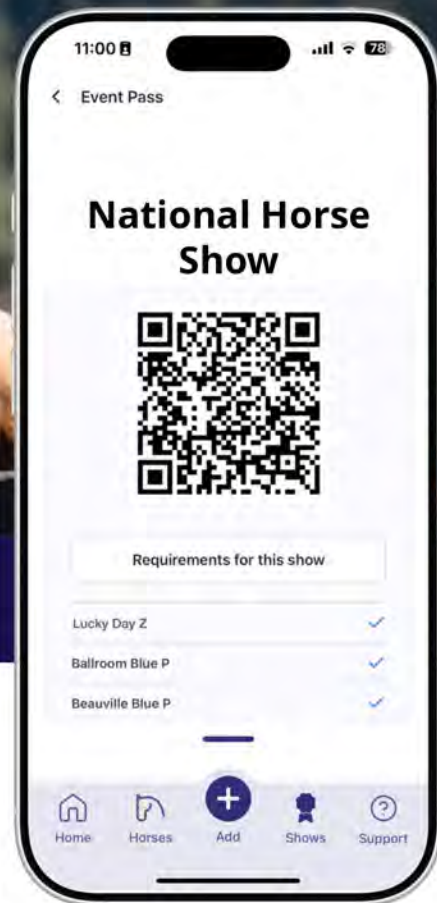
## ATTIRE

## USEF MOTORIZED VEHICLE RULE

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

## USEF MEMBERSHIP STATEMENT

"Every Class offered herein, which is covered by the rules and specifications of the current United States Equestrian rule book will be conducted and judged in accordance therewith."

**Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; and 7) assistant handlers in Dressage Sport Horse Breeding classes.**

## USEF ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable-casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. If not currently a USEF Active Competing member or Subscriber and competing only in classes that are exempt from membership requirements, I acknowledge and agree that I will be enrolled at no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew unless and until USEF determines in its sole discretion to terminate my Fan account. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

In order to be eligible riders may never have competed in any of the following National Equitation Finals with fences at 3'6": The NHS ASPCA Maclay National Championship, US Medal Finals, USEF Talent Search (East or West), WIHS Equitation Classic Finals, Jump Canada Medal Finals or the North American Equitation Championship. Provided they are otherwise eligible, riders may compete in any ASPCA Maclay Regional Championship Class and in the NHS 3'3" Equitation Championship Sponsored by the Hamel Foundation in the same year. Riders may not show in both the NHS 3'3" Equitation Championship Sponsored by the Hamel Foundation and the NHS ASPCA Maclay National Championship in the same competition year.

### JUDGING

To be judged on seat, hands, guidance and control of the horse.

### PRELIMINARY ROUND

To be shown over a course of not less than eight obstacles.

A minimum of twenty-four (24) riders, if available, are required to show at a walk, trot and canter.

### FINAL ROUND (NHS 3'3" Equitation and NHS Adult Amateur Equitation Championships Only)

A minimum of twenty-four (24) riders will be asked to return for a final round over a second course following the above listed specifications.

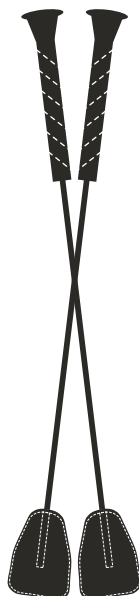

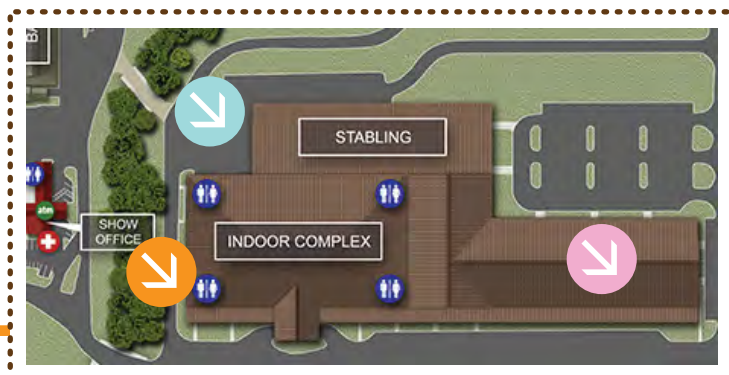

# EQUITATION CHAMPIONSHIPS AND FINALS

## Competition and Schooling Protocol

In an effort to promote a level playing field for all competitors, trainers, and their equine partners at the NHS ASPCA Maclay National Championship, the NHS 3'3" Equitation Championship Sponsored by the Hamel Foundation and the NHS Adult Equitation Championships sponsored by THIS (Equitation Finals) the National Horse Show will implement a schooling protocol.

The schooling protocol described below will be in effect for all Equitation Finals in 2026:

1. All horses competing in the ASPCA Maclay Final must be on the competition grounds no later than twelve (12) hours prior to the start of the warm up class and remain on the competition grounds until they have completed every phase of the event for which they are qualified to compete. All horses competing in the NHS 3'3" Equitation Championship Sponsored by the Hamel Foundation and the NHS Adult Equitation Championships sponsored by THIS must be on the competition grounds no later than twenty four (24) hours prior to the start of the class and remain on the competition grounds until they have completed every phase of the event for which they are qualified to compete. Any horse being used in the Equitation Finals, or that may potentially be used, must be entered and will be assigned a number which must be displayed at all times whenever outside of their stall, mounted or un-mounted. Only horses that have been assigned numbers and are on the competition grounds twelve hours prior to the start of warmup class will be eligible to be used as a replacement.
2. The USEF Steward(s) and/or USEF Schooling Supervisor(s) shall monitor all training and warmup areas to ensure equine welfare, soundness, competitor safety and to prevent overcrowding. In the event of any observed unsoundness, the Competition Veterinarian must be called immediately to make a determination whether the horse is serviceably sound. If the horse is determined to be unsound during a schooling session, it must stop working and may be re-presented prior to the competition. If the horse is determined to be not serviceably sound prior to or during the competition, the Competition Veterinarian may eliminate the horse from the competition.
3. Any rider, trainer, or groom found to be training a horse in an excessive manner, in the opinion of a USEF designated schooling supervisor(s) or USEF Steward(s) assigned to the class, may result in elimination of the horse and rider from the class. The trainer may be subject to further review for the violation by the USEF Hearing Committee. All incidents of excessive training or questions that are not addressed will be referred to a committee comprised of the USEF Staff representative(s), the USEF designated schooling supervisor or the USEF Steward(s) assigned to the class, and a representative of competition management. The USEF official who renders the opinion to the Committee will not participate in the Committee's decision which will be final.
4. Equitation Schooling Area:
  - Official schooling area will be set one hour before the start of the competition.
  - Schooling fences will be set as a straight line of oxers across the middle of the official schooling area
  - Each jump will have at least four standards, four rails and four cups.
  - Each jump must be flagged.
  - Each jump may be set as an oxer.
  - Each jump may be set as a vertical.
  - Each jump may be set as a combination-Bounce, One Stride or Two Strides.
  - Tarps (vinyl panels) and coolers are to be allowed. These may be used on the jump, under the jump or on the ground in front of or behind the jump. If they are used on the ground in front of or behind the jump they must be set on the ground a minimum of 9 feet and a maximum of 21 feet from the jump in either direction. They may not be set in such a way that they interfere with either the approach or landing of another jump.
  - Straight lines may not be set.
  - bending lines may not be set.
  - All other USEF Schooling rules for the equitation section will be enforced.

**Class 200**  
**\$75,000 NATIONAL HORSE SHOW HUNTER CLASSIC**

***No Entry Fee.***

***Formal attire is required.***

This class will be conducted under USEF General Rules and drug testing procedures. Horse-and rider combinations will compete at the respective height of the section from which they qualified.

The class consists of two rounds. Both of which will be judged by two judging panels consisting of two judges each. The open numerical scoring system will be utilized with each panel's score announced and then averaged to determine a final average numerical score for each horse. The top twelve (12) horses will be called back for a second round from low to high score within their respective heights. The height section including the horse with the highest first round average score shall return last. The second round should include elements that allow horse and rider to demonstrate brilliance and rideability, no trot fences will be permitted. Each round of the Classic is to count 50%. The final average score from Round One will be added to the final average score from Round Two to determine the overall total final score.

In case of a tie in either the first or second round: Panel One's score is the tie-breaker. In case of a tie in the overall standings: Panel One's second round score is the tie-breaker.

**QUALIFYING**

Invitations will be extended to the 1<sup>st</sup> through 6<sup>th</sup> place ribbon winning horse and rider combinations in over fence classes from each of the professional hunter divisions, models and under saddles not to count. A horse must be ridden by the same rider throughout the entire hunter section (exception: under saddle classes) to be eligible to compete in the Hunter Classic. Horses must jump the fence heights applicable to the section from which that horse and rider combination qualify. Qualifying is based on the horse-and-rider combination; no horse or rider substitutions allowed. Riders may qualify a maximum of two (2) horses.

When qualifying from more than one section, the qualifying horse and-rider combination will compete in the Hunter Classic from the section from which they have the highest number of points on the championship chart. In the case of an equal amount of points in more than one (1) section, the horse-and-rider combination will compete in the Hunter Classic from the section from which they first qualified.

Declarations to show in the Hunter Classic qualifying from one of the following hunter sections: Green 3'6", Green 3'9", Green Conformation, High Performance Conformation, High Performance Hunter must be made in the horse show office on Wednesday, October 28, 2026 within 1 hour of the conclusion of each rider's last eligible section.

**NOMINATION FEE:** \$250.00. To be eligible for the Jumper Division horses must be nominated and the nomination fee of \$250.00 paid by the closing date of entries. Horses nominated after that date must pay a nominating fee of \$275.00. Once a horse is nominated, it becomes eligible to compete in 1.40m Open Jumper and 1.30m Open Jumper.

**DECLARATIONS:** Classes must be declared by 9:00 AM the day of the class.

**JUMP ORDER:** A starting order will be drawn and rotated for 1.30M classes 210, 211 and 1.40M classes 215, 216. A separate order will be drawn for 1.35m Open Jumper Classic class 212 and 1.45m Open Jumper Classic class 217.

**TIES:** Ties involving first place in the Jumper Division must be jumped off (See JP143 & 146.3). Horses that are tied for other than first place will be placed based on their time in the first round.

**ATTIRE:** Formal Attire required for all classes.

**RECORDING:** All horses must be registered with the USHJA. Jumpers must be recorded with the USEF in order to receive points towards any USEF or USHJA Zone Horse of the Year awards.

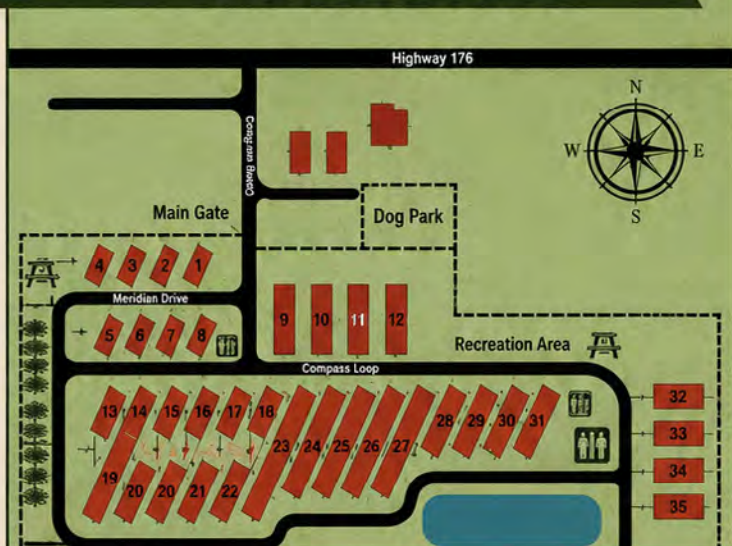

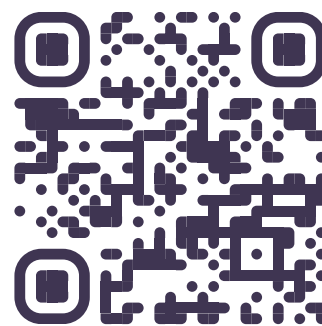

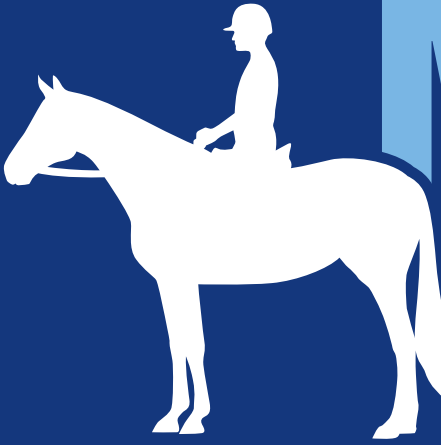

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and  
The National Horse Show ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at [www.usef.org](http://www.usef.org), as amended from time to time.

B. ACKNOWLEDGMENT OF INHERENT RISKS: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with equine activities, including but not limited to horseback riding and equestrian sport, are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").
